**POSITION:** School Nurse  
**LOCATION:** Center for Autism

**PRIMARY FUNCTION:** Provides medical, health, and wellness services to students, support staff, and faculty. Administers medication, provides illness detection and first-aid services, and related professional nursing services as required and all treatments prescribed by the student's personal physician within the guidelines of the Virginia Nurse Practice Act. Coordinates procedures for sending an ill/injured student home or to medical treatment facilities. Screens vision, hearing, dental, including referrals and follow-up. Serves as a health resource person to school staff, parents and community. Organizes the health clinic at the assigned school.

**QUALIFICATIONS:** Graduation from an accredited nursing program with a Registered Nurse license (bachelor's degree in nursing preferred) and some nursing experience working with health related issues inherent in school age students with Autism, Intellectual, and Emotional Disabilities. Certification in cardiac pulmonary resuscitation (CPR), and hearing/vision screening. Certified in applied suicide intervention skills and training-desirable. Certified Handle With Care – Crisis Intervention. Thorough knowledge of principles and practices of emergency and routine nursing care for school age children and young adults as well as adult staff and faculty. Thorough knowledge of vision/hearing/ dental screening and referral procedures and of medical and social service resources available in the community.
